

OFFICIAL RULES
COMO 1907 & CAGLIARI CALCIO SUMMER 2025 CAMP SWEEPSTAKES
(the “Sweepstakes”)

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING AND THE ODDS OF WINNING DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE RESTRICTED OR PROHIBITED BY LAW.

This Sweepstakes is sponsored by Como 1907 Srl (“Como”) and Cagliari Calcio SpA (“Cagliari”) (the “Sponsors”, “we”, “our” or “us”). By participating in the Sweepstakes and/or by accepting, using or benefiting from all or any portion of the Grand Prize, each entrant unconditionally agrees to and accepts these Official Rules as a legally binding and enforceable contract. PRIZES INVOLVE, AMONG OTHER THINGS, TRAVEL TO ITALY AND PARTICIPATION IN A SPORTS CAMP, BY MINOR CHILDREN. CONSEQUENTLY, CONSENT AND AUTHORIZATION BY AN ADULT PARENT OR LEGAL GUARDIAN IS REQUIRED. PRIZES DO NOT INCLUDE TRAVEL, ACCOMODATION OR OTHER ARRANGEMENTS FOR ANY PARENT, LEGAL GUARDIAN OR ADULT ACCOMPANYING A CHILD WHO IS SELECTED AS A POTENTIAL WINNER AND SUCH ARRANGEMENTS ARE SOLELY THEIR RESPONSIBILITY.

WHO IS ELIGIBLE: The Sweepstakes is open only to individuals who will be at least 13 years old on January 1, 2025, but not more than 18 years old on August 30, 2025 and you must be a legal resident of the United States, except for residents of the States of New York and Florida who are not eligible to participate or win.

A parent or legal guardian is permitted to enter for you if you are eligible to participate, but whether you, or your parent or legal guardian, submit an entry, your parent or legal guardian will be required to also complete necessary affidavits of eligibility, permissions, consents, approvals, releases and in every way be responsible for compliance with all the terms and conditions that apply to your participation, acceptance and use of any prize that may be awarded to you. If your parent or legal guardian is unwilling or unable or fails to complete and sign any documents or instruments reasonably required – including necessary travel documentation – you will be disqualified and forfeit any right to receive a prize.

Employees, officers, directors, managers, owners and with either of the Sponsors or of Società Sportiva Dilettantistica Sardinia Sport Event Srl (doing business as Sardinia Events) a company that is providing part of the prize consideration, and/or any of their respective licensees, advertising agencies, suppliers and contractors, as well as employees, officers, directors, managers, owners or investors of any parent, subsidiary or company affiliated with any of these entities (individually and/or collectively, the “Affiliated Entities”), and any immediate family members (spouse, parents, siblings and children) or individuals residing in the same household as any these individuals are not eligible to enter or participate in the Sweepstakes or win the Grand Prize.

ENTRY PERIOD & DEADLINE: The Sweepstakes begins on Wednesday, June 5, 2024 at 12:01:00 a.m. Eastern Standard Time (“EST”) and ends at 11:59:59 p.m. EST, on June 10, 2024 (the “entry period”) and your entry must be received by us before the end of the entry period in order to be entered and eligible to win. Proof of your submission of an entry will not be considered to be proof we received your entry within the entry period and we are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries, which will be disqualified. The date and time of our actual receipt of your entry, as recorded by our systems, is the sole and exclusive mechanism by which your entry will be considered received or not received within the entry period.

HOW TO ENTER: No purchase is necessary to enter or win. During the entry period specified above, eligible individuals who wish to enter can do so by (a) visiting the Sponsor’s activation booth at The Soccer Tournament (TST) held in Cary, North Carolina where you can complete an online entry form or (b) go online and visit our Sweepstakes website at

No other methods of entry are or will be accepted.

IMPORTANT: Only one (1) entry is permitted for each eligible individual, regardless of the method you use to enter. The date of your entry will be determined by the date and time stamp on our systems and communications networks (or if mailed, by the postmark) and not when you did or believe you did send or transmit the entry to us. Our decision is final and binding. If you submit more than one (1) entry, regardless of the mechanism, we have the right to disqualify you and you will be ineligible to participate or win a prize.

PRIZES: Two (2) Grand Prizes will be awarded. Each Grand Prize consists of the following:

- One Grand Prize winner will be awarded a one week participation at the Como summer camp: [Summer Camp - Como 1907 \(comofootball.com\)](https://comofootball.com) and the other Grand Prize Winner will be offered a choice of either the 5, 6 or 7 day program participation at the Cagliari summer camp: <https://sardiniasportevent.it/>. Both these camp programs will take place during the Summer of 2025 and each Grand Prize winner will be entitled to select to attend and participate from the available programs from June through August of 2025. Sardinia Events is providing promotional consideration for the Sweepstakes, but is not a sponsor of, nor in any way responsible or liable for the Sweepstakes.
- The Grand Prize includes roundtrip coach economy class air transportation from the major international airport nearest to the Grand Prize Winner’s legal residence to either Malpensa or Linate Airports (for the Como Summer Camp winner) or to the Cagliari Elmas Airport on the Italian island of Sardinia (for the Cagliari Summer Camp winner) and return; airport-hotel-airport transfers on the day of arrival and departure. Sponsors require all travel to be arranged by the Grand Prize winner using Sponsor’s designated concierge service and all travel arrangements must be reserved, finalized and confirmed on or before January 1, 2025 or the Grand Prize will be forfeit. If there is more than one major airport near the Grand Prize Winner’s legal residence, the Grand Prize winner will be asked to select her or his preferred airport from a list of major international airports provided by the Sponsor’s concierge service.
- Representatives of the Sponsor will meet each Grand Prize winner on arrival at Cagliari Elmas Airport and arrange transportation to the accommodations for the camp and will arrange transportation back to the airport on the day of departure.
- In addition, the Grand Prize includes accommodation, usually double occupancy, including all meals and snacks routinely available at each camp, access to television, air conditioning, Wi-Fi and a private bathroom. The Grand Prize Winner (or the parent or legal guardian) may request accommodation for a private room, if preferable.
- Among other things, each camp program includes the presence of qualified staff, the applicable camp training kit, full progressive coaching with the teams’ coaches and some local cultural excursions.

The approximate retail value of each Grand Prize is \$5,000 and the approximate retail value of both Grand Prizes is \$10,000. Prices of airfare, ground transportation and other elements of the prizes are subject to change outside the control of the Sponsor. Sponsor reserves the right to substitute either or both Grand Prizes for a prize award of equal or greater value. Taxes, fees and all other costs and

expenses associated with the acceptance, receipt and use of all or any portion of each Grand Prize not expressly specified in these Official Rules are the sole responsibility of the Grand Prize Winner.

WINNER SELECTION & NOTIFICATION: Drawing for the Grand Prize will be conducted after the entry period ends, sometime on or about September 30, 2024, with the assistance of an independent judge or judging agency selected by the Sponsor (the “Sweepstakes Administrator”). The Sweepstakes Administrator will select two potential Grand Prize Winners at random from the eligible entries received during the entry period and attempt to notify each potential Grand Prize winner using the contact information provided in the individual’s entry form. If an initially selected potential Grand Prize winners cannot be notified within five (5) days after the drawing or receives the notice but fails to respond to the Sweepstakes Administrator or, if there is any non-compliance with these Official Rules at any time, that potential winner will be disqualified, the Grand Prize will be forfeited, and an alternate potential Grand Prize Winner will be selected at random from the remaining eligible entries received. Being declared the Grand Prize Winner and being awarded the Grand Prize is contingent upon your compliance with and fulfilling all Sweepstakes rules and requirements and we may disqualify you if you fail to do so.

In order to claim the Grand Prize, a Grand Prize Winner will be asked to complete, sign and return a number of forms, documents and instruments (“documentation”), including, but not limited to:

An Affidavit of Eligibility;

- A liability waiver;
- A publicity release (unless prohibited by law or regulation);
- Necessary travel, living and camp participation agreement, which may include documents required by each of the camps;
- Any other instruments, documents and forms reasonably required by the Sponsors.

The documentation will be made available on or about October 15, 2024, and must all be signed, if necessary notarized, and returned within seven (7) days of receipt. In addition, the same or corresponding documentation must also be signed by the Grand Prize winner’s parent or legal guardian, who will also be required to complete and sign any and all necessary parental consent and authorization documentation required in order for their minor child to be able to accept, be awarded and take advantage of the Grand Prize.

If all required documentation is returned as required, confirmed and authenticated by the Sweepstakes Administrator, the Grand Prize will be awarded. If a potential Grand Prize winner or the Grand Prize winner’s parent or legal guardian fails to complete, sign and return all required documentation within the required time period, that potential Grand Prize winner will be disqualified and declared ineligible and the Sweepstakes Administrator will select and contact the next alternate potential Grand Prize winner.

We reserve the right to require authentication and proof of compliance with these Official Rules before declaring any individual a Grand Prize Winner. We will issue an IRS Form 1099 to the Grand Prize winner for the fair market value of the Grand Prize, inclusive of sales or other transaction taxes. The decisions of the Sponsor in all respects applicable to the Sweepstakes, including, without limitation, eligibility of entrants, entries, proof or authentication of information, documentation, compliance with these Official Rules and award of the Grand Prize, are and will be final and binding in all respects.

It is the responsibility of the Grand Prize winner to arrive at the airport in time for the flights to and from the applicable airports, in each case with proper travel documentation (*e.g.*, valid Passport) and each Grand Prize winner must comply with all governmental, airport and airline requirements applicable to the flights. The Sponsor is not and shall not be responsible if the Grand Prize winner is or are unable to accept or use all or any portion of the Grand Prize due to any failure of the Grand Prize winner to qualify or comply with these Official Rules or any law, regulation or other rules or requirements that apply to acceptance, receipt or use of the Grand Prize.

Airline schedules, travel arrangements and other aspects of the Grand Prize are subject to change outside the control of the Sponsor. Sponsor will not be liable or responsible for any such changes. If the Grand Prize winner is not available or fails to arrive at the required time or times, fails to have proper and complete documentation for all or any portion of the travel associated with a Grand Prize award, fails to comply with any applicable restrictions, requirements or rules, or fails to comply with these Official Rules, the Grand Prize winner may be disqualified and the Grand Prize forfeit. Except for our right to substitute a prize of equivalent or greater value, the Grand Prize may not be assigned, transferred, substituted or exchanged, nor its cash equivalent allowed.

YOUR PRIVACY RIGHTS:

DISCLAIMER & RELEASE: By entering and participating in the Sweepstakes, each entrant (i) assumes responsibility for all risks and liability for any damages, losses or injury sustained, incurred, caused or claimed to be caused as a result of entering and participating in the Sweepstakes and/or the acceptance, awarding, receipt, use and/or misuse of the Grand Prize and (ii) releases and agrees to indemnify and hold the Sponsor and Affiliated Entities harmless from and against any and all losses, damages, liability, costs and expenses based on any demand, claim or cause of action associated with and/or arising out of participating in the Sweepstakes and/or the acceptance, awarding, receipt, benefit from and/or use (or misuse) of all or any portion of the Grand Prize, including, but not limited to, any claims based on rights of privacy and/or publicity.

DISPUTES: The interpretation and validity, all issues involving or related to these Official Rules and this Sweepstakes, including, without limitation, the rights and obligations of the parties, shall be construed, enforced and governed exclusively by the substantive laws of the State of North Carolina, without reference to any conflict of laws principles that might result in the application of the laws of any other jurisdiction. By entering, participating and/or accepting the Grand Prize, you agree that: (1) all decisions and determinations of the Sponsor are final and binding for all purposes relating to or

associated with the Sweepstakes; (2) any and all disputes, claims, controversies and causes of action arising out of or connected with this Sweepstakes, shall be resolved with you individually, without resort to any form of class action, and exclusively by arbitration in the State of North Carolina in accordance with the rules of the American Arbitration Association; (2) any and all arbitral awards, claims, judgments and other awards to you shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes not to exceed \$100, but in no event attorneys' fees; and (3) under no circumstances will you or anyone claiming under or through you, be permitted to seek, claim or obtain a judgment awarding, and you hereby waive all rights to claim, any indirect, incidental, consequential, punitive, special, exemplary and/or any other damages, regardless of the form of action or basis of the claim and whether or not foreseeable and regardless of whether a party has been notified of the possibility of such damages. **SOME JURISDICTIONS DO NOT ALLOW LIMITATIONS OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.**

GENERAL: We may disqualify you if you fail to comply with these Official Rules, if you are unable or unwilling to authenticate the information necessary to confirm you as the Grand Prize winner or if we believe you have been or are tampering, interfering with or disrupting any entries, the conduct or the operation of the Sweepstakes. If any of your activities are or may be in violation of criminal and/or civil law, we also reserve the right to seek damages to the fullest extent permitted by law and, in our sole determination and discretion, we may provide information to appropriate government and law enforcement authorities. We reserve the right to withdraw, discontinue, cancel, terminate, suspend or modify the Sweepstakes for at any time and/or for any reason, including, without limitation, fraud, misconduct, technical problems, human error or causes beyond our control that interfere with the administration, integrity, security or operation of the Sweepstakes, as determined by us in our sole discretion.
